Contracting officers may **restrict competition** to firms when they have reasonable expectation that two or more firms will respond to the solicitation and that award will be made at a fair market price.

◀ Sole Source (See FAR 19)

One of the quickest methods for procuring our services and solutions is the Sole Source method. FAR 19 allows sole source awards to concerns provided that:

Only one firm can satisfy the requirement (Note: This does not mean the only source exists, but means that there is only one qualified 8(a) SDVOSB, HUBZone available);

- The award will be less than \$5 Million; and
- The price is reasonable.



◀ **HUBZone Set-Aside (See FAR 18.115)**

Rule of Two: Contracting officers may **restrict competition** to firms when they have reasonable expectation that two or more firms will respond to the solicitation and that award will be made at a fair market price.
